Winners will compete for prizes on Sunday, August 26 from 3pm -6pm

Note: The Calaveras Has Talent competition is under the umbrella of Calaveras Youth Organization as was the Save the Music campaign

OFFICIAL RULES FOR CALAVERAS HAS TALENT

1. PROMOTION DATES

A. The Calaveras Has Talent (“Promotion”) will begin on April 1, 2018 and end on August 26, 2018.

2. ELIGIBILITY RESTRICTIONS

A. The Promotion is open to legal residents of CALAVERAS, AMADOR, OR TUOLUMNE COUNTY of any age. There will be 2 age categories:

- a 18 years of age (in high school) and younger,
- b 18 (beyond high school) and over.

The Calaveras Has Talent affiliated entities, advertising agencies, participating sponsors/promotional partners, are ineligible to participate or win.

B. All participants must accurately complete an entry form in its entirety, including a parent or guardian’s name and signature for any contestant under the age of 18 at the time of the event. **All participants (or their parent or legal guardian) must also fill out and submit the CONTEST AFFIDAVIT AND RELEASE.**

C. This is a family-oriented event and any act found not to be in keeping with that type of activity **will either be denied entry or will be pulled from the stage and removed from all judging** if need be.

D. **All decisions of the judges are final.**

3. APPLICATION

Calaveras Has Talent entrants may download the entry documents from calaverasyouth.org. or entrants may pick-up entry documents at audition locations. Completing the entry forms and participating in the event, also gives Calaveras Has Talent and other media the right to capture video and audio images of all performances and use those captured images and sounds in news coverage of the event or promotion for future years’ events of this type.

4. WINNER SELECTION AND NOTIFICATION

A. Decisions of Calaveras Has Talent Show management with respect to the Promotion are final.

B. Contestants who submit acceptable video clips will be notified by an authorized representative of Calaveras Has Talent no later than July 15.

C. Winners of the Calaveras Has Talent competition will be selected by a panel of judges during the competitions of August 24-26, 2018. Judges will make decisions based on a variety of criteria.

5. CONDITIONS

A. Participating in the Promotion and acceptance of prize constitutes winners’ permission for the Calaveras Has Talent Show or its agents to photograph, film and record each winner, and to use his/her name, address (city and state), likeness, photograph, voice, biographical information and/or any statements made by him/her regarding the Promotion.

B. Prior to awarding any prize or prize certificate, and depending on the nature of the prize and eligibility requirements of the Promotion, the Calaveras Has Talent Show in its sole discretion will require verification of Promotion winner’s identification by a showing of valid photo identification. By

participating and/or accepting a prize, entrants, winners and guests (if applicable) agree to release and hold harmless the Calaveras Has Talent Show, its sponsor(s) and promotional partner(s), its advertising and promotion agencies, and any affiliated entities, officers, representatives, successors, and assigns of each of them (collectively, the "Released Parties") harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the Promotion.

C. The Calaveras Has Talent Show, in its sole discretion, reserves the right to disqualify any person (and all of their entries) from this Promotion if he or she tampers with the entry process, the operation of the Promotion, or the operation of the Calaveras Has Talent Show. The Calaveras Has Talent Show further reserves the right, at its sole discretion, to modify, cancel, terminate or suspend the Promotion, or any part of it, if it is not capable of completion as planned or if there is any fraud, technical failures or any factor beyond the Calaveras Has Talent Show's control.

RIGHTS OF THE CALAVERAS HAS TALENT SHOW / DISCLAIMER OF LIABILITY: THE CALAVERAS HAS TALENT SHOW shall have the right and sole discretion to edit, to refuse to air or cease to air any Submission whatsoever which it finds to be in violation of the provisions hereof, or which it finds in its sole but reasonable discretion to be otherwise objectionable for any reason, including with respect to broadcast standards and practices and other program policies. THE CALAVERAS HAS TALENT SHOW also reserves the right to replace the Prize Winning Submissions with the Submission of an alternate prize. THE CALAVERAS HAS TALENT SHOW also reserves the right, in its sole discretion, to close or extend the Entry Period at any time and/or to cancel, terminate, modify, or suspend the Competition for any reason, including, but not limited to, computer virus, hardware, or software failure, power failure, financial hardship, strikes by any affiliate, venue conflict, etc. human intervention violating these rules, or acts of God. In the event that there is an error, problem or cause which impacts the operation, administration or security of the Competition or the Competition Entities and, in such situation, to select the winner(s) from the eligible Entries received prior to the action taken or in such CALAVERAS HAS TALENT reserves the right to cancel or reschedule the event.

RIGHTS of the CONTESTANT

The contestant may submit an original audition video clip, or audition in person at any location where Calaveras Has Talent is holding auditions. At the discretion of the judges, a contestant may receive a "do over" ticket to try to improve a first attempt audition effort.

OFFICIAL RULES: These Official Rules are subject to revision by Event Organizers of THE CALAVERAS HAS TALENT SHOW at any time until the competition ends and if changes are made, changes will be posted on The Calaveras Has Talent Show Website, CalaverasYouth.org. 1. Photograph me and record my voice and likeness for the purpose of the production mentioned above, whether by film, videotape, magnetic tape, digitally or otherwise;
2. Make copies of the photographs and recordings so made;
3. Use my name and likeness for the purposes of education, promotion, publicity or advertising, including the sale or trading in the photographs, recordings and any copies so made.

I further understand the master tape of performances remains the property of Calaveras Has Talent Show and that there will be no restrictions on the number of times that my name and likeness, specific to the Calaveras Has Talent show and/or future shows may be used. I received no compensation for my performance.
